

NOTICE OF INTENT TO LIEN

Verified by the oath of REDI-MIX, INC. / Harold Pierce files this notice in writing, who has personal knowledge of the facts set forth herein;

That REDI-MIX, INC., intends to place a lien upon the following property situated in Shelby County, Alabama, to wit;

A parcel of land situated in the NW 1/4 of the SW 1/4 of Section 29, Township 21 South, Range 2 West, being more particularly described as follows: Commence at the SE corner of the NW 1/4 of the SW 1/4 of Section 29, Township 21 South, Range 2 West; thence North 0 degrees, 33 minutes, 00 seconds West for a distance of 399.41 feet to the point of beginning; thence continue along the last described course for a distance of 198.67 feet; thence South 87 degrees, 40 minutes, 52 seconds West for a distance of 236.99 feet to a point on the Easterly right of way line of Interstate Highway Number 65, also a part on a curve to the right having a central angle of 30 degrees, 36 minutes, 07 seconds and a radius of 379.18 feet, said curve having a chord bearing South 16 degrees, 28 minutes, 36 seconds West and a chord distance of 200.12 feet; thence along the arc of said curve and along said right of way line for a distance of 202.52 feet; thence North 89 degrees, 27 minutes, 00 seconds East and leaving said right of way for a distance of 295.47 feet to the point of beginning: being situated in Shelby County, Alabama.
