Unexpired insurance at Sale. Any unexpired insurance shall inure to the benefit of, and pass to, the purchaser of the Property covered by this Mortgage at any trustee's sale or other sale held under the provisions of this Mortgage, or at any foreclosure sale of spich Property.

Compliance with Existing Indebtedness. RIGHTS AND NUMBERS ON DEFAULT. Upon the occurrence of any Event of Default and at any time thereafter, Lander, at its option, may exercise any ions or more of the following rights and remedies, in addition to any other rights or remedies provided by law:

Accelerate Indebtedness. Lender shall have the right at its option without notice to Grantor to declare the entire indebtedness immediately due and payable, including any prepayment penalty which Grantor would be required to pay.
