MORTGAGE

THIS MORTGAGE IS DATED AUGUST 6, 1999, between DENNIS E. STEPHENS and JUDITH M. STEPHENS, HUSBAND AND WIFE, whose address is 2028 BRIDGELAKE DRIVE, BIRMINGHAM, AL. 35244 (referred to below as "Grantor"); and AmSouth Bank, whose address is 35 Church Street, Birmingham, AL. 35213 (referred to below as "Lender").

GRANT OF MORTGAGE. Grantor presently assigns to Lender all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property. In addition, Grantor grants to Lender a Uniform Commercial Code security interest in the Personal Property and Rents.

Improvements. The word "improvements" means and includes without limitation all existing and future improvements, buildings, structures, mobile homes affixed on the Real Property, facilities, additions, replacements and other construction on the Real Property.

Indebtedness.
