PARTIAL RELEASE OF LIEN 003 CRY 13.30

The State of Alabama Department of Revenue does hereby release and relieve the following real property located in Shelby County, State of Alabama, and more particularly described as follows:

a commercial building located at Highway 25, Harpersville, AL 35078
(more particularly described on Exhibit "A" attached hereto)
of and from the operation of a certain 100% penalty assessment for unpaid corporate tax lien filed by the Department of Revenue in the State of Alabama, Secretary of State's Office in the amount of \$22,009.63 against Gordon Lamar Cagle.

The purpose of this partial release of lien is to release and relieve the above-described real property from any claim of the State of Alabama, Department of Revenue under its tax lien recorded in State of Alabama, Secretary of State's Office, T 95-52653 FS and Jefferson County, Probate Court, Real Property Book 9601 at page 1090.

Pursuant to the June 4, 1999 Order of the U.S. Bankruptcy Court, Northern District of Alabama, Southern Division, Case No. 96-1413-TBB-13, Gordon Lamar Cagle has been authorized to sell the aforementioned real property. The residual balance of proceeds from the sale will be paid to the Chapter 13 Trustee of Mr. Cagle's bankruptcy action. The Department of Revenue's claim for 100% penalty assessment for unpaid corporate tax will be paid by the Trustee in the order of priority of claims.

The Department of Revenue's lien otherwise remains in full force and effect as to

all other property owned by Gordon Lamar Cagle.
