Beginning at a found 2" open top pipe corner representing the southwest corner of the SE 1/4 of the SE 1/4 of Section 18, Township 21 South, Range 2 West, Alabaster, Shelby County, Alabama and run thence North 01 deg. 07 min. 09 sec. West along the west line of said 1/4-1/4 a distance of 200.00 feet to a set 1/2" steel rebar corner; thence run South 88 deg. 52 min. 51 sec.
