

**ARTICLES OF INCORPORATION
OF

The undersigned, acting as Incorporator of a Corporation under the Code of Alabama, effective October 1, 1999, adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation is: **Two Chefs, Inc.**

PURPOSES

The purposes for which the Corporation is organized are for operating a restaurant and the transaction of any or all lawful business for which Corporations may be incorporated under the Alabama Business Corporation Act.

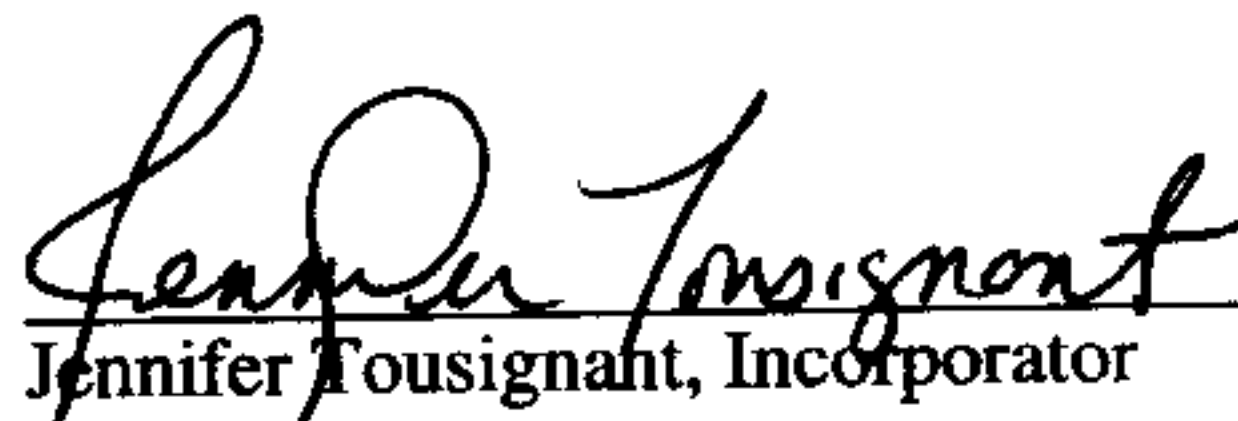
