MORTGAGE

THIS MORTGAGE IS DATED SEPTEMBER 10, 1998, between CHARLES A. FELL, III and DOREEN C. FELL, HUSBAND AND WIFE, whose address is 804 RIVERCHASE PARKWAY WEST, BIRMINGHAM, AL 35244 (referred to below as "Grantor"); and AmSouth Bank, whose address is 1849 Montgomery Highway, Birmingham, AL 35244 (referred to below as "Lender").

GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages, grants, bargains, sells and conveys to Lander all of Grantor's right, title, and interset in and to the following described real property, together with all existing or subsequently erected or affixed buildings, improvements and fixtures; all essements, rights of way, and appurtenances; all water, water rights, watercourses and ditch rights (including stock in utilities with ditch or irrigation rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar matters, located in SHELBY County, State of Alabama (the "Real Property"):

The Real Property or its address is commonly known as 804 RIVERCHASE PARKWAY WEST, BIRMINGHAM, AL 35244.

Grantor presently assigns to Lander all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property in addition, Grantor grants to Lander a Uniform Commercial Code security interest in the Personal Property and Rents.

DEFINITIONS. The following words shall have the following meanings when used in this Mortgage. Indebtedness.
