**PARTIAL RELEASE OF MORTGAGE**





Commence at the Northwest corner of Section 13, Township 21 South, range 1 East; thence run East along the North line of said Section 13 a distance of 1157.49 feet to the point of beginning; thence turn an angle of 118 degrees 04' 57" to the right and run a distance of 47.17 feet to a point on the Northeast R/W of Mardis Ferry Road; thence turn an angle of 68 degrees 15' to the left and run along said R/W a distance of 162.85 feet; thence turn an angle of 106 degrees 58' to the left and run a distance of 173.80 feet to a point on the Southwest margin of the Old Mardis Ferry Road; thence turn an angle of 94 degrees 27' 42" to the left and run along said old road a distance 165.75 feet; thence turn an angle of 90 degrees 19' 18" to the left and run a distance of 66.61 feet to a point on the North line of Section 13, and the point of beginning.
