KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of One Hundred Sixty-Eight Thousand Nine Hundred and no/100 Dollars (\$ 168,900.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, **UNITED HOMEBUILDERS, INC.**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **CATHERINE P. CRUTHIRDS & ROBERT J. CRUTHIRDS**, (herin referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 19A, according to the Survey of Oak Park, Sector 2, Phase 1, as recorded in Map Book 24, page 120, in the Probate Office of Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way and covenants of record; taxes for 1999 and subsequent years not yet due and payable.

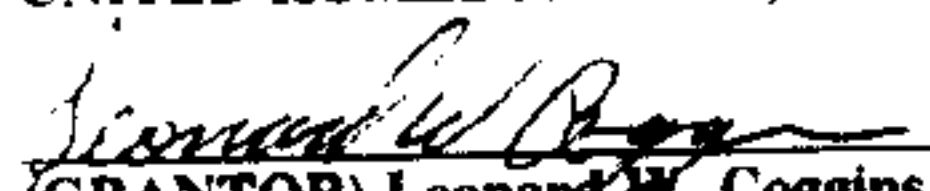
\$ 160,450.00 of the purchase price recited herein was paid from the proceeds of a mortgage loan closed simultaneously herewith.

IN WITNESS WHEREOF, the Grantor has signed and sealed this Deed on the **29th** day of **September, 1999**.

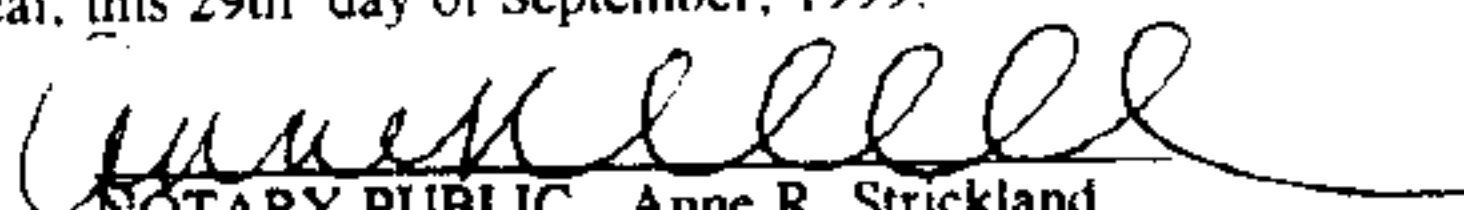
