**GENERAL WARRANTY DEED-Joint Tenants with Rights of Survivorship**

THAT IN CONSIDERATION OF FIVE HUNDRED AND NO/00 (\$500.00) to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I, **AMY L. COLEMAN, A SINGLE PERSON**

(herein referred to as Grantor(s)) grant, sell, bargain and convey unto  
**AMY L. COLEMAN AND RUSSELL W. HEINSMAN**
