after first having been duly sworn, said Affiants do hereby depose and say as follows:

1. The Affiants have personal knowledge of the facts stated herein, and are familiar with the family history of Cliffortine Harris, the decedent herein.
2. Said Cliffortine Harris died while residing in Shelby County, Alabama, on or about the 23rd day of JANUARY, 1999. During the period of her lifetime, said Cliffortine Harris obtained a parcel of real estate located in Montevallo, Shelby County, Alabama, hereinafter designated as follows:
