MORTGAGE

THIS MORTGAGE IS DATED OCTOBER 4, 1999, between FARRIS W. CROW, KELLEY P. RHEA and SHARON CROW, WITH TITLE VESTED AS FARRIS W. CROW & WIFE SHARON CROW, & KELLEY P. RHEA, UNMARRIED, whose address is 7920 WYNWOOD LANE, HELENA, AL 35080 (referred to below as "Grantor"); and AmSouth Bank, whose address is 931 Noble Street, Anniston, AL 36201 (referred to below as "Lender").

GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages, grants, bergains, sells and conveys to Lender all of Grantor's right, title, and interest in and to the following described real property, together with all existing or subsequently erected or affixed buildings, improvements and fixtures; all essements, rights of way, and appurtenances; all water, water rights, watercourses and ditch rights (including stock in utilities with ditch or irrigation rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar matters, located in SHELBY County, State of Alabama (the "Real Property"):

The Real Property or its address is commonly known as 7920 WYNWOOD LANE, HELENA, AL 35080.

Grantor presently assigns to Lender all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property. In addition, Grantor grants to Lender a Uniform Commercial Code security interest in the Personal Property and Rents.

DEFINITIONS. The following words shall have the following meanings when used in this Mortgage. Terms not otherwise defined in this Mortgage shall have the meanings attributed to such terms in the Uniform Commercial Code.
