KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of One Hundred Seventy Thousand Nine Hundred and No/100 Dollars (\$170,900.00) the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged **TAMBRIDGE BUILDING COMPANY, INC.**, an Alabama Corporation (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **DAMON S. FELTMAN & WENDY A. FELTMAN**, (herein referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 119, according to the Survey of Lake Forest, First Sector, as recorded in Map Book 24, Page 62, in the Probate Office of Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way and covenants of record; taxes for 2000 and subsequent years not yet due and payable.

\$ 153,800.00 of the purchase price recited herein was paid from proceeds of a mortgage loan closed simultaneously herewith.

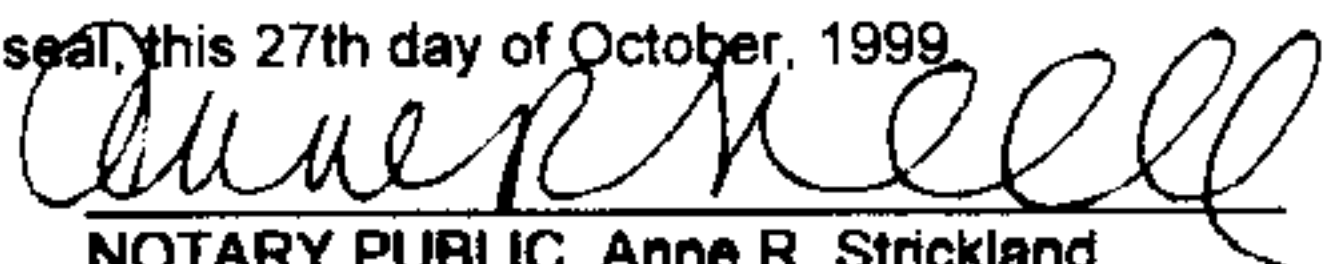
