DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

THIS DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS is made and entered into as of the 28th day of ______, 1999 by SIDNEY W. SMYER, III, a/k/a as S.W. Smyer, III, an unmarried man ("Declarant").

WHEREAS, Declarant is a party to the June 2, 1998 Declaration of Covenants and Restrictions; Quitclaim Deed; and Agreements recorded as Instrument #1998-20485 in the Office of the Judge of Probate of Shelby County, Alabama (the "Declaration"), as amended by the First Amendment thereto recorded as Instrument #1998-20486 in said Probate Office (the "Amendment"); and

WHEREAS, under the terms and provisions of Section 6.B of the Declaration, Declarant agreed to place certain restrictions and limitations on real property owned by Declarant which is designated in the Declaration as the "Highway 41 Acreage"; and

WHEREAS, the Highway 41 Acreage is legally described in Exhibit A attached hereto and made a part hereof.

NOW THEREFORE, in consideration of the premises and in compliance with the terms and provisions of Section 6.B of the Declaration, Declarant hereby subjects the Highway 41 Acreage to the following covenants, conditions and restrictions:

- (1) The Highway 41 Acreage shall be subdivided into no more than two lots restricted to single family residential use only, each of which may be improved with a residence containing a minimum of 2,000 heated square feet, except that Declarant shall retain the right to use any such residence located on the most easterly lot of the Highway 41 Acreage to operate as his farm or real estate office through May 2012;
- (2) Neither of said lots comprising the Highway 41 Acreage shall have access to or from Hollybrook Lake Road, as described in the Declaration; and
- (3) Neither of the two lots comprising the Highway 41 Acreage may be subdivided without the express written consent of the Hollybrook Lake Corporation, an Alabama corporation.

Declarant hereby declares that the Highway 41 Acreage shall be held, developed, sold, conveyed, leased, occupied and used subject to the covenants, conditions and restrictions set forth herein which shall be deemed to be covenants running with the land, binding upon the
