- 8. COLLECTION OF INDESTEDNESS FROM THIRD PARTY. Lender shall be entitled so notify or require Mortgagor to notify any third party including, but not limited to lessees, licensees, governmental authorities and insurance companies) to pay Lender any indebtedness or obligation owing to Mortgagor with respect to the Property (cumulatively "Indebtedness") whether or not a default exists under this Mortgagor. Mortgagor shall diligently collect the Indebtedness owing to Mortgagor from these third parties until the giving of such notification. In the event that Mortgagor possesses or receives possession of any instruments or other remittances with respect to the Indebtedness following the giving of such notification or if the instruments or other remittances constitute the prepayment of any Indebtedness or the payment of any insurance or condemnation proceeds. Mortgagor shall hold such instruments and other remittances in trust for Lender apart from its other property, endorse the instruments and other remittances. - 13. CONDEMNATION. Mortgagor shall immediately provide Lender with written notice of any actual or threatened condemnation of emineral domain proceeding pertaining to the Property. Mortgagor shall immediately provide Lender with written notice of and indemnify and hold Lender and its shareholders, directors, officers, employees and agents harmless from all claims, damages, liabilities (including attorneys' fees and legal expenses), causes of action, actions, suits and other legal proceedings (cumulatively "Claims") pertaining to the Property (including, but not limited to, those involving Hazardous Materials). - 17. INSPECTION OF PROPERTY, BOOKS, RECORDS AND REPORTS. - EVENTS OF DEFAULT. An Event of Default will occur under this Mortgage in the event that Mortgagor, Borrower, or any guaranter of the Ohligations:

(a) fails to make any payment under this Obligation, any other document or instrument relating to the foregoing or executed in favor of Lender. or under any other indebtedness to Lender when due;

(b) fails to perform any obligations or breaches any warranty or covenant to Lender contained in this Mortgage or any other present or timure written agreement regarding this or any other indebtedness to Lender:

(c) provides or causes any false or misleading signature or representation to Lender;

(d) sells, conveys, or transfers rights in the Property without the prior written approval of Lender;

(e) seeks to revoke, terminate or otherwise limit its liability under any continuing guaranty;

(f) has a garnishment, judgment, tax levy, attachment or lien entered or served against any of them or any of their property. (g) dies, becomes legally incompetent, is dissolved or terminated, coases to operate its business, becomes insolvent makes an assignment for

the benefit of creditors, or becomes the subject of any bankrupacy, insolvency or debtor rehabilitation proceeding;

(h) fails to provide Londer pvidence of satisfactory financial condition; or (i) has a majority of its outstanding voting securities or other ownership interest sold, transferred or conveyed to any person or entity other than any person or entity that has the majority ownership as of the date of the execution of this Mortgage

In addition, an Event of Default will occur under the Obligations in the event that:

20. RIGHTS OF LENDER ON EVENT OF DEFAULT. Upon the occurrence of an Event of Default under this Mortgage. Lender shall be entitled to energise one or more of the following remedies without notice or demand (except as required by law):

(a) to declare the Obligations immediately due and payable in full, such acceleration to be automatic and immediate if the Event of Default is a

filing under the Bankruptcy Code;

(b) to collect the outstanding Obligations with or without resorting to judicial process; (c) to require Mortgagor to deliver and make available to Lender any personal property or Chattels constituing the Property at a place

reasonably convenient to Mortgagor and Lender; (d) to enter upon and take possession of the Property without applying for or obtaining the appointment of a receiver and, at Lender's option, of appoint a receiver without hond, without first bringing suit on the Ohligations and without otherwise meeting any statutory conditions regarding

receivers, it being intended that Lender shall have this contractual right to appoint a receiver; (e) to employ a managing agent of the Property and let the same, in the name of Lender or in the name of Mortgagor, receive the rents, incomes, issues and profits of the Property and apply the same, after payment of all necessary charges and expenses, on account of the

(f) to pay any sums in any form or manner deemed expedient by Lender to protect the security of this Mongage or to cure any default other

than payment of interest or principal on the Obligations; (g) to foreclose this Mortgage under the power of sale and in accordance with the requirements of law or by judicial action, at Lender's election,

(h) to set-off Mortgagor's Obligations against any amounts owed Mortgagor by Lender including, but not limited to, morses, instruments, and deposit accounts maintained with Lender or any currently existing or future affiliate of Lender; and

(i) to exercise all other rights available to Londer under any other written agreement or applicable law.

If Morigagor is in default under this Morigage, this Morigage shall be subject to foreclosure at Lender's option. Notice of the exercise of such opinion is expressly waived by Mortgagor, and Lender shall have the right to enter upon and take possession of the Property, and after, or without taking consession of the property, to sell the Property at the front or main door of the country where the Property is located, at public entery for each, after first giving notice of the description of the property to be sold and the time, place, and terms of such sale by publication once a week for three consecutive weeks prior to the sale in a newspaper published in the country or counties in which the property to be sold is included, Mortgagor waives any requirement that the Property be sold in separate tracts and agrees that Lender may sell the Property on masse regardless of the number of parcels conveyed by this Mortgage. .22. REIMBURSEMENT OF AMOUNTS EXPENDED BY LENDER. Lender, at Lender's option, may expend funds (including anormeys' feet and legal expenses) to perform any set required to be taken by Mortgagor or to exercise any right or remedy of Lender under this Mortgage. Upon demand, Mortgagor shall immediately reimburse Lender for all such amounts expended by Lender together with inscress thereon at the lower of the highest rate described in any Obligation or the highest rate allowed by law from the date of payment until the date of reimbursement. These sums shall be included in the defination of Obligations herein and shall be secured by the beneficial interest granted herein. If the Obligations are paid after the beginning of publication of notice of sale, as herein provided, or in the event Lender shall, at its sole option, permit Mortgagor, to pay any part of the Obligations after the beginning of publication of notice of sale, as herein provided, then, Mortgagor shall pay on demand all expenses incurred by the Lender in connection with said publication, including reasonable attorneys' fees, and this Mortgage shall be security for all such expenses and fees.
