BORROWER'S TRANSFER TO LENDER OF RIGHTS IN THE PROPERTY l grant, bargain, sell and convey the Property to Lender. This means that, by signing this Mortgage, I am giving Lender the rights that i have in the Property subject to the terms of this Mortgage. The Lender also has those rights that the law gives to lenders who hold mortgages on real property. The Property will be sold to the highest bidder at the public auction. Notice of the time, place and terms of sale will be given by publishing the notice with a description of the Property once a week for three (3) successive weeks in a newspaper published in the county or counties in which the Property is located. I give a general warranty of title to Lander. This magns that I will be fully responsible for any losses which Lander suffers because someone other than myself has some of the rights in the Property-which I promise that I have. I promise that I will defend my ownership of the Property against any claims of such rights.

I promise and I agree with Lender as follows:

1. BORROWIR'S PROMISE TO PAY AMOUNTS ADVANCED UNDER THE AGREEMENT AND FINANCE CHARGES, AND TO FULFILL OTHER PAYMENT COLIGATIONS

2. LENDER'S APPLICATION OF SORROWER'S PAYMENTS

Unless the law requires or Lender chooses otherwise, Lander will apply each of my payments under the Agreement and under Paragraph 1 above in the following order and for the following purposes:

(A) First to pay finance charges then due under the Agreement; and (B) Next, to late and other charges, if any; and

(C) Next, to Lender's costs and expenses, if any; and

(D) Next, to pay any Advances made under the Agreement or payments made under this Mortgage.

3. SORROWER'S OBLIGATION TO PAY CHARGES AND ASSESSMENTS AND TO SATISFY CLAIMS AGAINST THE PROPERTY

I will pay all taxes, assessments, and any other charges and lines that may be imposed on the Property and that may be superior to this Mortgage. I will also make payments due under my lease if I am a tenant on the Property and I will pay ground rents (if any) due on the Property. I will do this by making payments, when they are due, directly to the persons antitled to them. (In this Mortgage, the word "person" means any person, organization, governmental authority, or other party.) Upon request, I will give Lender a receipt which shows that I have made these payments.

Any claim, defined or charge that is made against property because an obligation has not been fulfilled is known as a "lien". I will promptly pay or satisfy all liens against the Property that may be superior to this Mortgage. However, this Mortgage does not require me to satisfy a superior lien if: (a) I agree, in writing, to pay the obligation which gave rise to the superior lien and Lender approves the way in which I agree to pay that obligation; or (b) I, in good faith, argue or defend against the superior lien in a lewsuit so that, during the lawsuit, the superior lien may not be enforced and no part of the Property must be given:up.

Condominium Assessments

If the Property Includes a unit in a Condominium Project, I will promptly pay when they are due all assessments imposed by the owners association or other organization that governs the Condominium Project. That association or organization will be called the "Owners Association".

4. BORROWER'S OBLIGATION TO OBTAIN AND TO KEEP HAZARD INSURANCE ON THE PROPERTY

(A) Generally

I will obtain hazard insurance to cover all buildings and other improvements that now are or in the future will be located on the Property. The insurance must cover loss or damage caused by fire, hazards normally covered by "extended coverage" hazard insurance policies, and other hazards for which Lender requires coverage. The insurance must be in the amounts and for the periods of time required by Lender. Lender may not require me to obtain an amount of coverage that is more than the value of all buildings and other improvements on the Property.

I may choose the insurance company, but my choice is subject to Lander's approval. Lender may not refuse to approve my choice unless the refusal is reasonable. All of the insurance policies and renewals of those policies must include what is known as a "standard mortgages clause" to protect Lender. The form of all policies and the form of all renewals must be acceptable to Lender. Lender will have the right to hold the policies and renewals.

will pay the premiums on the insurance policies by paying the insurance company directly when the premium payments are due. If Lander requires, I will promptly give Lender all receipts of paid premiums and all renewal notices that I receive.

If there is a loss or damage to the Property, I will promptly notify the insurance company and Lender. If I do not promptly prove to the insurance company that the loss or damage occurred, then Lender may do so.

The amount paid by the insurance company is called "proceeds". The proceeds will be used to reduce the amount that I owe to Lender under

the Agreement and this Mortgage, unless Lander and I have agreed to use the proceeds for repairs, restoration or otherwise.

The Lander has the authority to settle any claim for insurance benefits and to collect the proceeds. Lander than may use the proceeds to reduce

the amount that I owe to Lender under the Agreement and under this Mortgage or to repair or restors the Property as Lender may see fit If any proceeds are used to reduce the amount that I owe to Lender under the Agreement, that use will not delay the due date or change the amount of any of my monthly payments under the Agreement and this Mortgage. However, Lender and I may agree in writing to those delays or changes.

If Lender acquires the Property by purchase at foreclosure sale, all of my rights in the insurance policies will belong to Lender. Also, all of my rights in any proceeds which are paid because of damage that occurred before the Property is acquired by Lender will belong to Lender. However, Lender's rights in those proceeds will not be greater than the amount that I owe to Lender under the Agreement and under this Mortgage.

(B) Agreements that Apply to Candeminiums

(i) If the Property Includes a unit in a Condominium Project, the Owners Association may maintain a hazard insurance policy which covers the entire Condominium Project. That policy will be delied the "master policy".
