**CORPORATION FORM WARRANTY DEED

That in consideration of \$135,550.00 to the undersigned Grantor, American Homes and Land Corporation, in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto Todd P. Stephens and D'Ann D. Stephens (herein referred to as Grantees) Husband and Wife as joint tenants with right of survivorship, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 307, according to the Survey of Old Cahaba Oak Ridge Sector, as recorded in Map Book 25, Page 59 in the Office of the Judge of Probate of Shelby County, Alabama.

Property to become the Homestead of the Grantees.

Subject to taxes for the year 2000 and subsequent years, easements, restrictions, reservations, rights-of-way, limitations, covenants and conditions of record, if any, and mineral and mining rights, if any.
