EXHIBIT A**LEGAL DESCRIPTION**

Commence at the Southwest corner of Southeast quarter of Southwest quarter of Section 35, Township 17, Range 1 East, this being point of beginning of the tract herein described; from said point go East along South line of said forty 400 feet to a point; thence left and parallel with the East line of said forty a distance of 210 feet to a point; thence West and parallel with the South line of said forty a distance of 400 feet to the West line of said forty; thence South along West line a distance of 210 feet to a point of beginning.
