As further consideration and security for the Debt, Mortgagor represents, coveriants, warrants, and agrees with the Mortgagee, its successors and assigns, as follows:

- 1. Mortgagor shall keep the improvements now existing or hereafter located on the Property continuously insured against loss. by fire, vandalism, and maticious mischief, including standard extended coverage, and any other hazards for which Mortgagee requires. insurance. If the Property is now or shall in the future become located in a designated "flood prone" area pursuant to the Flood Disaster. Protection Act, the Mortgagor shall obtain flood insurance and shall comply with the National Flood Insurance Program. The loss, if any, on all insurance policies required herein shall be payable to the Mortgagee as its interest may appear. This insurance shall be maintained in an amount at least equal to the full insurable value of the improvements located on the Property (except that flood insurance shall not exceed the maximum amounts allowable pursuant to the National Flood Insurance Program). The insurance companies providing the insurance shall be with such companies as may be satisfactory to the Mortgagee. All insurance policies and renewals shall be acceptable. to Mortgagee and shall include a standard mortgagee's clause.
