

AMENDED ARTICLES OF ORGANIZATION

ARTICLE I

NAME

DURATION

Dailey & Grisham Properties, L.L.C. shall not endure for more than ninety (90) days beyond the occurrence of an event of dissociation as listed under Alabama Code Section 10-12-36, subject only to the rights of at least two (2) remaining members, or one remaining member and one new member to continue the company's business and legal existence by unanimous written consent given within those ninety (90) days.

ARTICLES III

Dailey & Grisham Properties, L.L.C. has been organized for the following purposes: (i) to buy, sell, own, trade and otherwise handle and deal in all kinds of personal and real property whatsoever, and to render services of all kinds and descriptions; and (ii) to transact such other business as may be permitted under the laws of the State of Alabama.

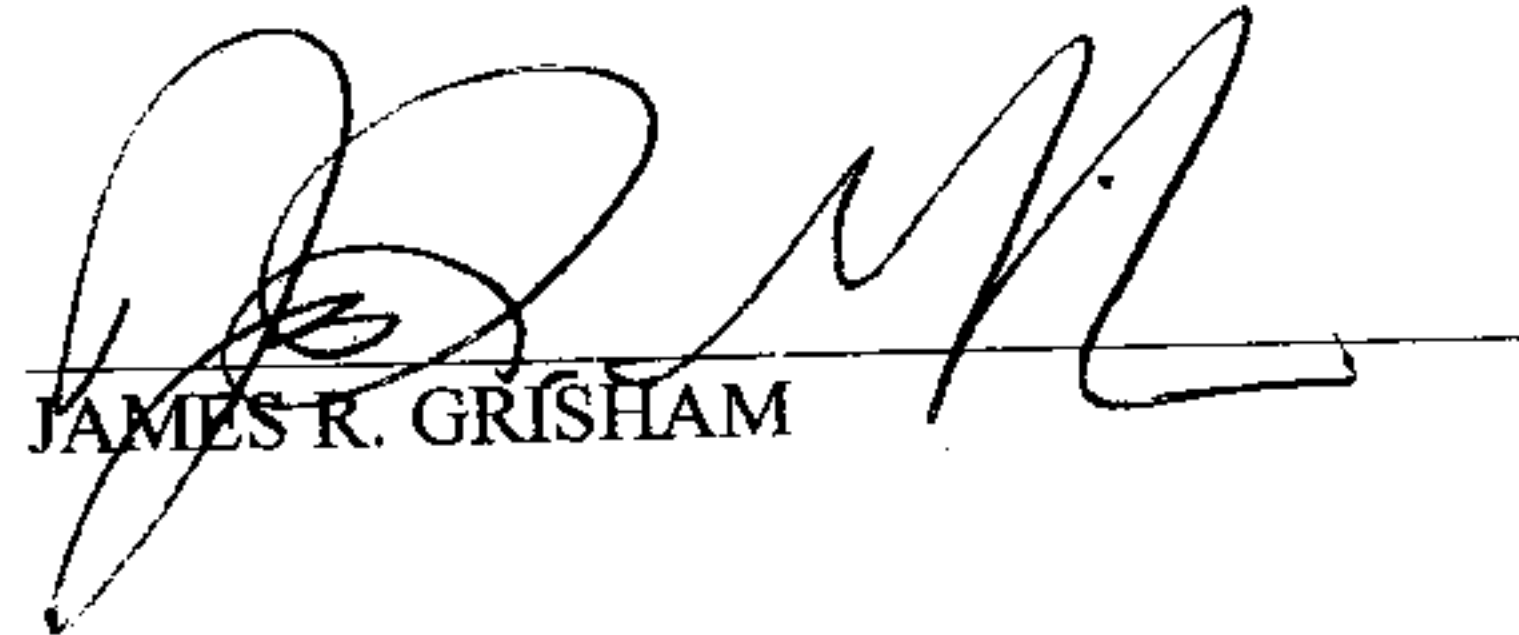
TRANSFERABILITY OF INTERESTS
