WARRANTY; DEFENSE OF TITLE. The following provisions relating to ownership of the Property are a part of this Mortgage

Default on Other Payments. Feilure of Grantor within the time required by this Mortgage to make any payment for taxes or insurance. Of any other payment necessary to prevent filing of or to affect discharge of any lien.

Compliance Default. Failure of Grantor to comply with any other term, obligation, covenant or condition contained in this Mortgage, the Note or in any of the Related Documents.

False Statements. Any warranty, representation or statement made or furnished to Lender by or on behalf of Grantor under this Mortgage the Note or the Related Documents is false or misleading in any material respect, either now or at the time made or furnished.

Defective Collegeralization. This Mortgage or any of the Related Documents ceases to be in full force and effect (including failure of any collegeral documents to create a valid and perfected security interest or lien) at any time and for any reason.

Death or Insolvency. Grantor also will pay any court costs. in addition to all other sums provided by law. Grantor agrees to pay attorneys' fees to Lender in connection with closing, amending or modifying the loan.
