Know All Men by These Presents: That in consideration of THIRTY NINE THOUSAND FIVE HUNDRED AND NO/100 (\$39,500.00) DOLLARS to the undersigned grantor, A Corporation), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, SAVANNAH DEVELOPMENT, INC. (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto DAVID L. LOVE AND DONNA W.
