PROMISSORY NOTE

TWENTY-FIVE THOUSAND DOLLARS
(\$25,000.00)

BIRMINGHAM, ALABAMA
MAY 15, 1987

The undersigned, for value received, promises to pay to the order of DOROTHY ADELF the sum of TWENTY-FIVE THOUSAND AND NO/100 DOLLARS (\$25,000.00), together with interest thereon at the rate of NINE AND ONE-HALF PER CENT (9-1/2%) per annum, in fifty-nine (59) monthly installments of \$261.06 commencing on June 15, 1987, payable on the fifteenth (15th) day of each month thereafter, with one final payment of \$20,435.50 due on May 15, 1992, the maturity date, payable at Route 2, Box 865, Pelham, AL 35124, or at such other place or places as the owner or holder hereof may from time to time designate. All payments shall be applied first to interest on the unpaid balance of principal, and the balance to principal.

In the event of default under the terms of this note, the holder hereof shall have the right and option to declare the entire indebtedness secured hereby to be at once due and payable.

The undersigned maker hereby waives all rights of exemption under the Constitution and Laws of Alabama, and agrees to pay the cost of collection, including a reasonable attorney's fee, if this obligation is not paid at maturity.

Demand, protest and notice of protest, and all requirements necessary to hold it liable, are hereby waived by the makers of this Note.
