**CORPORATION FORM WARRANTY DEED

That in consideration of \$ 170,600.00 to the undersigned Grantor, American Homes and Land Corporation, in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto Stanley J. Bara and Kristyn Bara, Husband and Wife, and Fred White a married man not joined by (herein referred to as Grantees) as joint tenants with right of survivorship, the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 275, according to the Map and Survey of Eagle Point, 2nd Sector, Phase 4, as recorded in Map Book 25, Page 103 in the Probate Office of Shelby County, Alabama.

Property to become the Homestead of the Grantees Stanely J. Bara and Kristyn Bara but not the Homestead of Grantee Fred White.

Subject to taxes for the year 2000 and subsequent years, easements, restrictions, reservations, rights-of-way, limitations, covenants and conditions of record, if any, and mineral and mining rights, if any.
