MORTGAGE

THIS MORTGAGE IS DATED DECEMBER 2, 1999, between MICHAEL A. MCSWAIN and BRENDA C. MCSWAIN, HUSBAND AND WIFE, whose address is 1433 SECRETARIAT DRIVE, HELENA, AL. 35080 (referred to below as "Grantor"); and AmSouth Bank, whose address is 1900 5th Avenue North, Birmingham, AL. 35203 (referred to below as "Lender").

GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages, grants, bargains, sells and conveys to Lender all of Grantor's right title, and interest in and to the following described real property, together with all existing or subsequently erected or affixed buildings improvements and fixtures; all easements, rights of way, and appurtenances; all water, water rights, watercourses and ditch rights (including stock in utilities with ditch or irrigation rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar metters, located in SHELBY County, State of Alabama (the "Real Property"):

The Real Property or its address is commonly known as 1433 SECRETARIAT DRIVE, HELENA, AL 35080.

Grantor presently assigns to Lender all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property in addition. Grantor grants to Lender a Uniform-Commercial Code security interest in the Personal Property and Rents.

DEFINITIONS. The following words shall have the following meanings when used in this Mortgage. Improvements. The word "Improvements" means and includes without limitation all existing and future improvements, tautdings structures, mobile homes affixed on the Real Property, facilities, additions, replacements and other construction on the Real Property

Indebtedness. Title.
