

Mayor Roy introduced the following Ordinance:

**ORDINANCE NO. 2000-04**

WHEREAS, on or about the 27<sup>th</sup> day of December 1999, Mr. D. L. Bowers/McCullough Oil Company filed a petition with the City Clerk of the City of Calera, Alabama as required by 11-42-20 and 11-42-21, Code of Alabama 1975, as amended, petitioning and requesting that the property hereinafter described be annexed to the municipality of the City of Calera, Alabama, which petition contained an accurate description of the property proposed to be annexed together with a map of the said property showing its relationship to the corporate limits of the City of Calera, Alabama, and the signature of the owner of the property described were signed thereto;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CALERA, AS FOLLOWS:**

1. That the City of Calera, Alabama does adopt this Ordinance assenting to the annexation of the property owned by the above referenced property owner, as described in:

to the municipality of the City of Calera, Alabama.

2. That the corporate limits of the City of Calera, Alabama, be extended and rearranged so as to embrace and include such property, and such property shall become a part of the corporate area of such municipality upon the date of publication or posting of this Ordinance, as provided for in the Code of Alabama as cited above.

That the City Clerk be and she is hereby authorized and directed to file a copy of this ordinance, including an accurate description of the property being annexed, together with a map of the said property showing its relationship to the corporate limits of the City of Calera, Alabama, to which said property is being annexed in the office of the Judge of Probate of Shelby County, Alabama.

4. That the Zoning Map of the City of Calera, Alabama and any other official maps or surveys of the City shall be amended to reflect the annexation of the above described property, and that a copy of this Ordinance be transmitted to the City Planning Commission and the Zoning Administrator.

Council Member Davis moved that Ordinance No. 2000-04 be adopted, which motion was seconded by Council Member Glasgow and upon vote the results were as follows:



Commence at the northwest corner of the NW 1/4 of the NW 1/4 of Section 32, Township 21 south, Range 2 West, Shelby County, Alabama and run thence easterly along the north line of said 1/4 - 1/4 section a distance of 708.74' to a point on the easterly right of way line of the Alabama Power Company Easement or Right of Way; thence turn 69 degrees 58 minutes 38 seconds right and run southeasterly 15.83' to a point; thence turn 12 degrees 08 minutes 55 seconds left and run southeasterly along said easement or right of way line 609.12' to a point; thence turn 2 degrees 14 minutes 23 seconds right and continue along said right of way or easement line a distance of 70.47' to the point of beginning of the property being described; thence continue along last described course a distance of 155.32' to a point; thence turn 105 degrees 02 minutes 39 seconds right and run westerly a distance of 430.93' to a point on the easterly right of way line of Shelby County Highway No. 87 in a curve to the left having a radius of 1,493.08'; thence turn 104 degrees 35 minutes 36 seconds right and run north northeasterly along the chord of said right of way curve a chord distance of 154.63' to a point; thence turn 75 degrees 21 minutes 16 seconds right from chord and run easterly a distance of 351.62' to the point of beginning, containing 1.35 acres.
