

# ARTICLES OF INCORPORATION

#### Article I

The name of the corporation is Teresa Stahl, Inc.

#### Article II

The period of its duration is perpetual.

#### Article III

The purpose or purposes for which the corporation is organized are to provide real estate agent services and to engage in any lawful act or activity for which a corporation may be organized under the Alabama Business Corporations Act.

#### Article IV

The aggregate number of shares of capital stock which the corporation shall have the authority to issue is 100 shares of common stock, par value \$10 per share.

#### Article V

#### Article VI

## Article VIII

Each shareholder shall have a pre-emptive right to purchase shares of any class of capital stock of the corporation, including treasury shares.

## Article IX

The corporation shall have the right to purchase, take, receive or otherwise acquire, hold, own, pledge, and transfer or otherwise dispose of its own shares. Purchase by the corporation of its own shares, whether direct or indirect, may be made to the extent of unreserved and unrestricted earned surplus and capital surplus of the corporation available therefor.
