## ORDINANCE FOR UNANIMOUS CONSENT

WHEREAS, on the 20th day of December, 1999, Jack W. Kidd, being the owner of all the real property hereinafter described, did file with the Town Clerk a petition asking that the said tracts or parcels of land be annexed to and become a part of the Town of Harpersville; and

WHEREAS, said petition did contain the signatures of all of the owners of the described territory and a map of said property showing its relationship to the corporate limits of the Town of Harpersville; and

WHEREAS, the governing body did determine that it is in the public interest that said property be annexed to the Town of Harpersville and it did further determine that all legal requirements for annexing said real property have been met pursuant to Sections 11-42-20 through 11-42-24, Code of Alabama, 1975;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF Harpersville, ALABAMA, AS FOLLOWS:

Section 1. The Council of the Town of Harpersville, Alabama, finds and declares as the legislative body of the Town that it is in the best interests of the citizens of the Town, and the citizens of the affected area, to bring the territory described in Section 2 of this ordinance into the Town of Harpersville.

Section 2. The boundary lines of the Town of Harpersville, Alabama, be, and the same are hereby altered or rearranged so as to include all of the territory heretobefore encompassed by the corporate limits of the Town of Harpersville, Alabama, and in addition thereto the following described territory, to-wit:
