

**ARTICLES OF INCORPORATION  
OF

To the Honorable Patricia Yeager Fuhrmeister, Judge of Probate  
of Shelby County, Alabama:

We the undersigned, desiring to become a body corporate, do hereby file the following Articles of Incorporation, pursuant to the laws of the State of Alabama, and the undersigned Incorporators do hereby make and subscribe their names to these Articles.

**ARTICLE 1: NAME**

The name of the corporation shall be **SSE LOCK AND KEY, INC.**

**ARTICLE 2: OBJECTS**

The corporation has been organized for the following purposes: retail and commercial locksmith services, the purchase of related real estate, and the transaction of any or all lawful business for which corporations may be incorporated under this chapter. The corporation is a corporation organized for profit and shall be perpetual in duration.

**ARTICLE 3: PRINCIPAL OFFICE AND REGISTERED AGENT**

The principal office of the corporation shall be at 1770 Indian Hills Road, in Pelham, Alabama. The initial registered agent of the corporation authorized to receive service of process is Ron Jewell, whose address is 1770 Indian Hills Road, Pelham, Alabama 35124.

**ARTICLE 4: AUTHORIZED CAPITAL STOCK**

The number of shares which the corporation shall have the authority to issue is 3000 and the par value of each share shall be \$0.10 for a total authorized capital of \$300.00. If the shares are to be without par value, then "no par value" should be stated.

## ARTICLE 6: POWERS

- c) To engage in business as natural persons may, not inconsistent with the provisions of law pertaining to corporations in the State of Alabama.

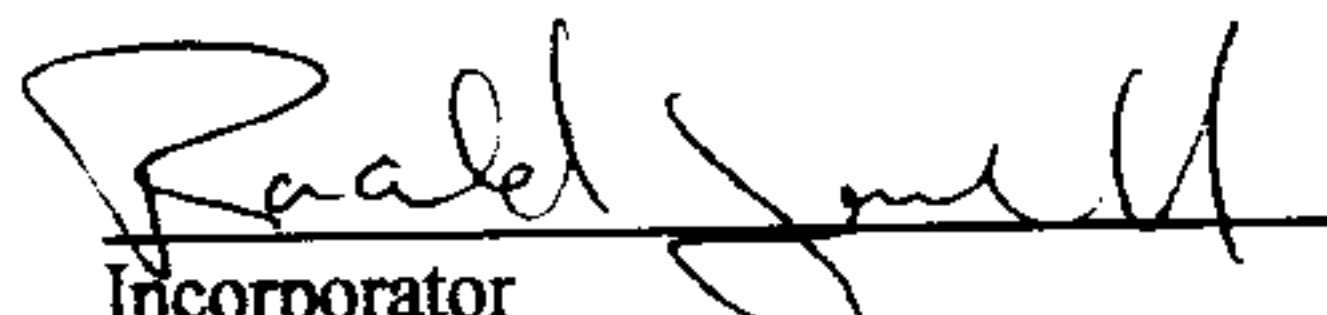
#### ARTICLE 7: RESTRICTIONS
