KNOW ALL MEN BY THESE PRESENTS.

COUNTY OF SHELBY)

That in consideration of TWO HUNDRED FIFTY EIGHT THOUSAND FIVE HUNDRED AND NO/100 DOLLARS (\$258,500.00), to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **JON P. STRENGTH AND WIFE, SANDRA L. STRENGTH**, (herein referred to as Grantors) do grant, bargain, sell and convey unto **MARK B. NALL AND ANGELA L. NALL** (herein referred to as Grantees), as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of SHELBY, to-wit:
