TO HAVE AND TO HOLD this property unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, apportenances, and fixtures now or hereafter a part of the property. 17. Transfer of the Property or a Beneficial Interest in Borrower.
