MORTGAGE THIS IS A FUTURE ADVANCE MORTGAGE

THIS MORTGAGE IS DATED JANUARY 20, 2000, between ARTHUR N. WIMBERLY and CARIE LANE JOHNSON WIMBERLY, HUSBAND AND WIFE, whose address is 4013 KINROSS LANE, BIRMINGHAM, AL 35242 (referred to below as "Grantor"); and AmSouth Benk, whose address is 1900 5th Avenue North, Birmingham, AL 35203 (referred to below as "Lender").

GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages, grants, bergains, sells and conveys to Lender all of Grantor's right, title, and interest in and to the following described real property, together with all existing or subsequently erected or affixed buildings improvements and fixtures; all easements, rights of way, and appurtenences; all water, water rights, watercourses and ditch rights (including stock in utilities with ditch or irrigation rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar matters, located in SHELBY County, State of Alabama (the "Real Property"):

The Real Property or its address is commonly known as 4013 KINROSS LANE, BIRMINGHAM, AL 35242.

Grantor presently assigns to Lender all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property. In addition, Grantor grants to Lender a Uniform Commercial Code security interest in the Personal Property and Rents.

DEFINITIONS. The following words shall have the following meanings when used in this Mortgage. Guerantor. The word "Guerantor" means and includes without limitation each and all of the guerantors, sureties, and accommodation parties in connection with the Indebtedness.

improvements. The word "Improvements" means and includes without limitation all existing and future improvements, buildings, structures, mobile homes affixed on the Real Property, facilities, additions, replacements and other construction on the Real Property.

indebtedness. The word "Indebtedness" means all principal and interest payable under the Credit Agreement and any amounts expended or advanced by Lender to discharge obligations of Grantor or expenses incurred by Lender to enforce obligations of Grantor under this Mortgage together with interest on such amounts as provided in this Mortgage and any and all other present or future, direct or contingent liabilities or indebtedness of any person who signs the Credit Agreement to the Lender of any nature whatsoever, whether classified as secured or unsecured, except that the word "Indebtedness", shell not include any debt subject to the disclosure requirements of the Federal Truth-in-Lending Act If, at the time such debt is incurred, any legally required disclosure of the lien afforded hereby with respect to such debt shall not have been made.
