Lot 128, according to the Survey of Graystone Legacy, 1st Sector as recorded in Map Book 26, Pages 79 A, 8 and C, in the Office of the Judge of Probate of Shelby County, Alabama.

The Property is conveyed subject to the following:

- Ad valorem taxes due and payable October 1, 2000, and all subsequent years thereafter.
- Library district assessments for the current year and all subsequent years thereafter.
- 3. Mining and mineral rights not owned by Grantor.
- All applicable zoning ordinances.
- 5. The essements, restrictions, reservations, covenants, liens, assessments, agreements and all other terms and provisions of the Greystone Legacy Declaration of Covenants, Conditions and Restrictions dated as of December 1, 1999 and recorded as Instrument No. 1999-50895 in the Office of the Judge of Probate of Shelby County, Alabams, as amended, (which, together with all amendments thereto, is hereinafter collectively referred to as the "Declaration").
