

**ARTICLES OF INCORPORATION OF
J.T. HAULING, INC.**

Pursuant to Alabama Code 1975, as amended, Section 10-2B-2. 02, the following Articles of Incorporation are set out:

- I. NAME: The name of the corporation is J.T. Hauling, Inc.
- II. AUTHORIZED SHARES: The corporation is authorized to issue one thousand (1,000) shares of common stock. There shall only be one class of stock.
- III. REGISTERED AGENT AND REGISTERED OFFICE: The street address of the corporation's initial registered office is 745 Camp Branch Circle, Alabaster, Alabama 35007 and the name of the initial registered agent at such office is Donald Franklin Jones.
- IV. INCORPORATOR: The incorporator for the corporation is Donald Franklin Jones whose address is 745 Camp Branch Circle, Alabaster, Alabama 35007.
- V. DIRECTORS: The corporation shall not operate with less than one director. The name and address for the individual's who is to serve as the initial directors is as follows: (a) President Donald Franklin Jones (b) Vice President Debra Ann Jones 745 Camp Branch Circle Alabaster, Alabama 35007.
- VI. PURPOSE: The purpose for which the corporation is organized, is for the operation of a independent hauling business and to transact any and all lawful business for which corporations may be incorporated under Alabama Code 1975 Section 10-2B-1.01 et seq.
- VII. LIMITATION OF LIABILITY: No director or shareholder of the corporation shall be liable to the corporation for money damages for any action taken, or any failure to take any action, as a director or as a shareholder, except liability for (i) the amount

of a financial benefit received by a director or shareholder to which he or she is not entitled; (ii) an intentional infliction of harm on the corporation; (iii) a violation of Alabama Code 1975 Section 10-2B-8.33; and (iv) an intentional violation of criminal Law; or (v) a breach of the director's duty of loyalty to corporation or its shareholders.
