MORTGAGE

THIS MORTGAGE IS DATED NOVEMBER 1, 1999, between RANDAL E. WEBS and TONIA R. GRANT OF MORTGAGE. Grantor presently assigns to Lender all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property in addition, Grantor grants to Lender a Uniform Commercial Code security interest in the Personal Property and Rents.
