## ORDER

The above-styled matter came on to be heard upon the filing of a PETITION FOR REMOVAL OF DISABILITIES OF NON-AGE. Present this date were the following: Cindy Sirmon, Guardian Ad Litem for Clair Sheehy Allison; the minor, Clair Sheehy Allison; said child's father, Thomas M. Allison; said child's mother, Pamala S. Allison; and Henry Taliaferro, Retained Counsel for Thomas M. Allison and Pamala S. Allison.

Henry Taliaferro, Counsel for the Petitioners, Thomas M. Allison and Pamala S. Allison, orally moved to add child's mother, Pamala S. Allison, as Co-petitioner. Motion GRANTED.

This Court ascertained that all parties were apprised of the nature of the pending allegations, the nature of the proceeding, the dispositional alternatives available to the Court and of rights, including the right to counsel, the right to a Guardian Ad Litem, and the right to a hearing.

This Court proceeded to hear the sworn testimony of Clair Sheehy Allison, Thomas M. Allison and Pamala S. Allison.

Wherefore, having considered the sworn testimony and the relevant, competent, and material evidence in addition thereto, and noting the concurrence of all parties present, this Court FINDS that it is in the best interest of the minor, Clair Sheehy Allison, to be relieved from the disabilities of non-age.

Wherefore, this Court ORDERS, ADJUDGES and DECREES that CLAIR SHEEHY ALLISON shall be relieved of the Disabilities of Non-Age. Such judgment shall have the effect of investing CLAIR SHEEHY ALLISON with the right to sue and be sued, to contract, to buy, sell and convey real estate, and generally, to do and perform all acts which such minor could lawfully do if 19 years of age.

Guardian Ad Litem fees in the sum of \$ 150.00 and Court costs in the sum of \$97.00 (TOTAL - \$247.00) are taxed to the Petitioners, THOMAS M. ALLISON AND PAMALA S. ALLISON. Said sums shall be paid to the Clerk of the Court by MARCH 21, 2000.
