**PARCEL #I:** Lot 27, according to the Survey of Olde Towne Forest, 1st Addition, as recorded in Map Book 9, Page 170, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

**PARCEL #II:** A part of Lot 28, Old Towne Forest, 1st Addition, as recorded in Map Book 9, Page 170, in the Office of the Judge of Probate, Shelby County, Alabama, being more particularly described as follows:

Commence at the Westernmost corner of said Lot 28, also being the Northernmost corner of Lot 27 in said Old Towne Forest 1st Addition; thence run in a southeasterly direction along the Southwest line of said Lot 28 and also the Northeast line of said Lot 27 for a distance of 128.98 feet to an iron pin set at the point of beginning; thence continue along last stated course for a distance of 74.13 feet to an iron pin found at the Southernmost corner of said Lot 28; thence turn an angle to the left of  $58^{\circ}44'00''$  and run in a Northeasterly direction along the Southeast line of said Lot 28 and also along the Northwest line of Lots 25 and 24 in said Old Towne Forest 1st Addition for a distance of 74.41 feet to an iron pin set; thence turn an angle to the left of  $154^{\circ}12'37''$  and run in a westerly direction for a distance of 89.58 feet to an iron pin set; thence turn an angle to the right of  $11^{\circ}19'41''$  and run in a northwesterly direction for a distance of 40.42 feet to the point of beginning.
