If Borrower pays Funds to Lender, the Funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a federal or state agency (including Lender if Lender is such an institution). Lender shall apply the Funds to pay said taxes, assessments, insurance premiums and ground rents. Lender may not charge for so holding and applying the Punds, analyzing said account or verifying and compiling said assessments and bills, unless Lender pays Borrower interest on the Funds and applicable law permits Linder to make such a charge. - 11. Successors and Assigns Bound; Joint and Several Liability: Co-signers. The covenants and agreements betein contained shall bind, and the rights bereunder shall inure to, the respective successors and assigns of Lender and Borrower subject to the provisions of paragraph 16 hereof.
