ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION GUIDELINES

INSTRUCTIONS

STEP 1: IF CHANGING THE CORPORATION'S NAME, CONTACT THE OFFICE OF THE SECRETARY OF STATE AT (334) 242-5324 TO RESERVE A CORPORATE NAME.

STEP 2: FILE THE ORIGINAL AND TWO COPY IN THE COUNTY WHERE THE ORIGINAL ARTICLES OF INCORPORATION ARE FILED (IF THE AMENDMENT CHANGES THE NAME, THE CERTIFICATE OF NAME RESERVATION MUST BE ATTACHED). IF CHANGING THE NAME, THE SECRETARY OF STATE'S FILING FEE IS \$20. THE SECRETARY OF STATE'S FILING FEE FOR ALL OTHER AMENDMENTS IS \$10.

PURSUANT TO THE PROVISIONS OF THE ALABAMA BUSINESS CORPORATION ACT, THE UNDERSIGNED HEREBY ADOPTS THE FOLLOWING ARTICLES OF AMENDMENT.

- Article I** The name of the corporation.
Treebert, Inc.
- Article II** The following amendment was adopted in the manner provided for by the Alabama Business Corporation Act.
To change the Corporate name to :
Ragtime Cafe, Inc.
- Article III** The amendment was adopted by the shareholders or directors in the manner prescribed by law on Oct. 1 19 99.
- Article IV** The number of shares outstanding at the time of the adoption was 1000; the number of shares entitled to vote thereon was 1000. (If the shares of any class are entitled to vote thereon as a class, the designation and number of outstanding shares entitled to vote thereon of each such class.)
- Article V** The number of shares voted for the amendment was 1000 and the number of shares voted against such amendment was 0. (If no shares have been issued write a statement to that effect.)
