ITEM TWO

To my son, Donald Eugene Jones, his father's Purple Heart medal on a chain, and the two oldest guns that are already in his possession. To my granddaughter, Sherry Jones, my wedding band. To my granddaughter, Tracy Jones, my dinner ring and the cedar chest only when she marries or establishes her own home. To my granddaughter, Misti Jones, my birthstone ring. To my granddaughter, Susie Jones, my ruby and diamond ring. To my grandson, little Ronnie Jones, the 410 automatic gun.

All remaining furniture is to remain in the homeplace and not be distributed among my heirs.

I hereby give, devise, and bequeath a life estate of my homeplace unto my children, Ronald Eason Jones, Donald Eugene Jones, Wanda Sue Jones McKinnon and Stanley Ray Jones during their lifetime. At the death of all my children, the estate is to be divided to the living heirs of my said children.

ITEM THREE

I hereby nominate and appoint my sons, Ronald Eason Jones and Donald Eugene Jones, as Joint Executors of this Last Will and Testament. I hereby direct that my said Joint Executors be relieved from giving any bond, filing inventory, or making annual or other return to any Court and empower them as Joint Executors to

If for any reason Ronald Eason Jones and Donald Eugene Jones cannot serve or fails or ceases to serve as my Joint Executors, then I appoint my daughter, Wanda Sue Jones McKinnon, as Executrix of this my Last Will and Testament, with the same rights and under the same conditions as herein set out for my aforementioned Joint Executors.
