together with all awards received through eminent domain, and payments upon any insurance policies covering the real estate, and all rights, privileges, tenements, and appurtenances thereunto belonging or in anywise appertaining to said real estate including easements and rights-of-way appurtenant thereto and all gas, steam, electric and other heating, cooling and lighting apparatus, elevators, iceboxes, plumbing, stoves, doors and other fixtures appartaining to the real estate and improvements located thereon, all of which shall be deemed realty and conveyed by this mortgage.

IO HAVE AND TO HOLD the real estate, and every part thereof, unto Mortgagee, its successors and assigns forever. THIS MORTGAGE IS MADE, however, subject to the following covenants, conditions, agreements, and provisions:

- 1. That Mortgagor shall pay the said indebtedness(es) secured hereby and interest thereon when and as it (they) shall become due, whether incourse or under any condition, coverant or agreement herein contained, together with any other indebtedness(es) which Mortgagor may own to Mortgagoe, it being further agreed that any statement, any note or obligation that is secured by this mortgage shall be conclusive evidence of such first.
- 2 (a) That Mortgager shall provide, maintain and deliver to Mortgages policies of fire insurance (with extended coverage), and such other insurance as Mortgages may from time to time require in companies, form, types, and amounts, and shall assign, with endorsements satisfactory to Mortgages and deliver to Mortgages with mortgages clauses satisfactory to Mortgages all insurance policies of any kind or in any amount now or hereafter issued with respect to the real estate. Not later than the first day following the expiration date of any and all such insurance policies and at any time upon request of Mortgages. Mortgages shall furnish Mortgages certificates of insurance issued by insurance companies satisfactory to Mortgages showing that the amount and type of insurance required by Mortgages hereunder is in effect. All renewal policies, with premiums paid, shall be delivered to Mortgages at least thirty (30) days before the expiration of the old policies. If any insurance, or any part thereof, shall expire.

or be withdrawn or become void or unsafe by Mortgagor's breach of any condition thereof, or become void or unsafe by reason of the failure or impairment of the capital of any company by which the insurance may then be carried, or if for any reason whatever the insurance shall be insatisfactory to Mortgagee, Mortgagor shall procure and deliver to Mortgagee new insurance on the premises, satisfactory to Mortgagoe ifrMortgagor shall procure and deliver such new insurance, Mortgagee may, but shall not be obligated to, procure same, and upon demand. Mortgagor shall procure in the note secured hereby. Mortgagoe shall give immediate notice in writing to Mortgagoe of any loss, injury or demage affecting the mortgaged real estate caused by any casualty or occurrence. Full power is hereby conferred on Mortgagoe tokettle and compromise claims under all policies and to demand, receive, and receipt for all montes becoming payable thereunder and to assign absolutely all policies to any holder of the note or to the grantee of the real estate in the event of the foreclosure of this mortgagee and security agreement or other tragsfer of title to the real estate in extinguishment of the indebtedness(es) secured hereby. In the event of loss covered by any of the policies of insurance herein referred to, each individual insurance company concerned is hereby authorized any deep test to make payment for such loss directly to the Mortgagee instead of to the Mortgagor and the Mortgagee jointly, and the insurance proceeds after make payment for such loss directly to the Mortgagee instead of to the Mortgagoe and the Mortgagee jointly, and the insurance proceeds after the indebtedness(es), secured hereby, whether or not then due or payable, or toward the restoration, reconstruction repair, or alteration of the real estate, either to the portion thereof by which said loss was sustained or any other portion thereof.

- (b) That together with and in addition to the monthly payment of principal and interest, and on the same date on which the principal and interest are payable under the terms of the note secured hereby, Mortgagor, if required by Mortgagoe, shall deposit with the Mortgagoe, in a non-interest bearing account, a sum equal to one-twelfth (1/12) of the yearly taxes and assessments which may be levied against the real estate and which may attain priority over this mortgage, and ground rents, if any, plus one twelfth (1/12) of the yearly premiums for insurance that will be come ittle and payable to retiew the insurance on the real estate for coverage against loss by fire or such other hazard as may reasonably be required by the Mortgagoe. The amount of such taxes, assessments, ground rents, and premiums when unknown, shall be estimated by the Mortgagoe if the amount of finals had exceed at any time the amount deemed necessary by the Mortgagoe to provide for the payment of taxes, assessments, ground conts and insurance premiums as they fall due, such excess shall be repaid to Mortgagor or credited to Mortgagoe any determine. If the amount of the funds held shall not be sufficient at any time to pay taxes, assessments, ground cents, and insurance premiums as they fall due, Mortgagoe shall pay to Mortgagoe any amount necessary to make up the deficiency upon notice from Mortgagoe to Mortgagor requesting payment thereof. Upon payment in full of all sums secured by this mortgage, Mortgagoe shall promptly refund to Mortgagor any funds held.
- (c) That Mortgagor shall pay and discharge as the same become due all taxes and assessments that may accrue, be levied, or assessed upon the real estate or any part thereof, which may be or become a lien prior to this mortgage or have priority in payment to the indebtedness(es) secured hereby, or upon Mortgages's interest therein or upon this mortgage or the indebtedness(es) or evidence of indebtedness(es) secured hereby, without regard to any law heretofore or hereafter enacted imposing payment of the whole or any part(s) thereof upon Mortgages, upon the passage of any law imposing the payment of the whole or any part thereof upon Mortgages or upon the rendering by an appellate court of competent journality at the undertaking by Mortgagor to pay such taxes is legally inoparative, then the indebtedness(es) secured hereby without deduction shall, at the option of Mortgages, become immediately due and payable, notwithstanding anything contained in this mortgage or any law heretofore enacted, and Mortgagor shall not suffer or permit any such taxes on the said real estate to become or remain delinquent or permit any part thereof or any interest therein to be sold for any taxes or assessments; and further shall furnish annually to Mortgages, prior to the date when they become delinquent certificates or receipts of the proper offices showing full payment of all such taxes and assessments.
 - 3. That the real estate and the improvements thereon shall be kept in good condition and no waste committed or permitted thereon.

That no building or other improvement on the real estate shall be structurally altered, removed or demolished, without the Mortgagee's prior written consent, nor shall any fixture or chattel covered by this mortgage and adapted to the proper use and enjoyment of the real estate be removed at any time without like consent unless actually replaced by an article of equal suitability owned by Mortgager. In the event of any breach of this covenant the Mortgagee may, in addition to any other rights or remedies, at any time thereafter, declare the whole of the indebtedness(es) secured himself interesting due and payable.
- 5. That Mortgagor agrees that the indebtedness(es) hereby secured shall at once become due and payable and this mortgage subject to foreclosure as provided for herein, at the option of holder hereof, when and if any statement of lien is filed under the statutes of Alabama relating to the liens of mechanics and materialmen, without regard to form and contents of such statement, and without regard to the existence or nonexistence of the debt or any part thereof, or of the lien, on which such statement is based.
- 6. That Mortgagor shall comply with all statutes, ordinances, regulations and laws promulgated by any governmental antity asserting jurisdiction over the real estate and any and all legal requirements shall be fully complied with by Mortgagor.
- 7. That if Mortgagor fails to insure the real estate as hereinabove provided, or to pay all or any part of the taxes or assessments lovied, accrued at assessed upon or against the real estate or the indebtedness(es) secured hereby, or any interest of Mortgagee in either, or fails to pay immediately and discharge any and all liens, debts, and/or charges which might become liens superior to the lien of this mortgage. Mortgagee may, at its option, insure the real estate and/or pay said taxes, assessments, debts, liens and/or charges and any money which Mortgagee shall have so paid shall constitute a debt to Mortgagee additional to the indebtedness(es) secured hereby, shall be secured by this mortgage; shall bear the interest set out in the note hereinabove referred to from date peid or incurred; and, at the option of Mortgagee, shall be immediately due and payable
- 8. That Mortgagor agrees that no delay or failure of Mortgages to exercise any option to declare the maturity of any indebtednessless secured by this mortgage, shall be taken or deemed as a waiver of its right to exercise such option, or to declare such forfeiture, either as to any past or prisent default, and it is further agreed that no terms or conditions contained in this mortgage can be waived, altered or changed except as evidenced in writing signed by the Mortgagor and by the holder hereof; and the procurement of insurance or the payment of taxes or other liens, debts or charges by Mortgages shall not be taken or construed as a waiver of its right to declare the maturity of the indebtedness(es) hereby secured by reason of the failure of Mortgagor to procure such insurance or to pay such taxes, debts, liens or charges
- 9 That if Mortgagee shall be made a party to any suit involving the title to the real estate and employs an attorney to represent it therein the Mortgagee employs an attorney to essist in settling or removing any cloud on the title to the real estate hereby conveyed that purports to be superior to the lien of this mortgage in any respect, Mortgager will pay to Mortgagee, when the same becomes due, such attorney's fee as may be permitted by law-and as may be reasonable for such services, and if such fee is paid or incurred by Mortgagee the same shall be secured by the her of this mortgage in addition to the indebtedness(es) secured hereby, and shall bear interest from the date it is paid or incurred at the rate set out in the note hereinsterive referred to and shall be at once due and payable.

That all expenses incurred by Mortgages, including attorney's fee, in compromising, adjusting or defending against lien claims or encumbrances sought to be fixed upon the real estate hereby conveyed, whether such claims or encumbrances be valid or not, shall become a part of the indebtedness(es) hereby secured.
- 11. That Mortgagor agrees to pay a reasonable attorney's fee as may be permitted by law to Mortgagee should the Mortgagee employ an attorney to collect any indebtedness(es) secured by this mortgage.
- 12. That notwithstanding that the assignment of awards hereinabove referred to shall be deemed to be self executing. Mortgagor, after the allowance of a condemnation claim or award, and the ascertainment of the amount due thereon, and the issuing of a warrant by the condemner for the payment thereof, shall execute, at Mortgagoe's request, and forthwith deliver to Mortgagoe, a valid assignment in recordable form, assigning all of such condomnation claims, awards or damages to Mortgagoe, but not in excess of an amount sufficient to pay, satisfy and discharge the principal sum of this mortgage and any advances made by Mortgagoe as herein provided then remaining unpaid, with interest thereon at the rate specified herein or in the note which this mortgage secures, to the date of payment, whether such remaining principal sum is then due or not by the terms of said note or of this mortgage.
