together with all awards received through eminent domain, and payments upon any imputance policies covering the real estate, and all rights, privileges, tenements, and appurtenances thereunto belonging or in anywise appertaining to said real estate including essements and rights-of-way appurtenant thereto and all gas, steam, electric and other fixtures appertaining to the real estate and improvements togeted thereon, all of which shall be deemed realty and conveyed by this mortgage.

TO HAVE AND TO HOLD the real estate, and every part thereof, unto Mortgages, its successors and assigns forever. And Mortgagor covenants with Mortgages that it is lawfully seized of the real estate in fee simple and has a good right to sell and convey the same as aforesaid that the real estate is free of all encumbrances except as herein set out, and Mortgagor will warrant and forever defend the title to the real estate unto Mortgagor its successors and assigns, against the lewful claims of all persons whomsoever.

THIS MORTGAGE IS MADE, however, subject to the following covenants, conditions, agreements, and provisions:

- 1. That Mortgagor shall pay the said indebtedness(es) secured heraby and interest thereon when and as it (they) shall become due, whether its course or under any condition, covenent or agreement herein contained, together with any other indebtedness(es) which Mortgagor may owe to Mortgagoe, it being further agreed that any statement, any note or obligation that is secured by this mortgage shall be conclusive evidence of such fact
- 2. (a) That Mortgagor shall provide, maintain and deliver to Mortgagee policies of fire insurance (with extended coverage), and such other insurance as Mortgagee may from time to time require in comparise, form, types, and amounts, and shall easign, with endorsements satisfactory to Mortgagee and deliver to Mortgagee with mortgagee clauses satisfactory to Mortgagee all insurance policies of any kind or in any amount new or hereefter issued with respect to the real estate. Not later than the first day following the expiration date of any and all such insurance policies and at any time upon request of Mortgagee. Mortgager shall furnish Mortgagee certificates of insurance issued by insurance companies satisfactory to Mortgagee showing that the amount and type of insurance required by Mortgagee hereunder is in effect. All renewal policies, with premiums paid, shall be delivered to Mortgagee at least thirty (30) days before the expiration of the old policies. If any insurance, or any part thereof, shall expire.

or be withdrawn or become void or unsafe by Mortgagor's breach of any condition thereof, or become void or unsafe by reason of the failure or impairment of the capital of any company by which the incurance may then be carried, or if for any reason whatever the insurance shall be unsaftisfactory to Mortgagee, Mortgagor shall procure and deliver to Mortgagee new insurance on the premises, satisfactory to Mortgagee. If Mortgagor fails to procure and deliver such new incurance, Mortgagee may, but shall not be obligated to, procure same, and upon demand. Mortgagor shall give immediate notice in writing to Mortgagee of any loss, injury or damage affecting the mortgaged real estate caused by any casualty or occurrence if full power is hereby conferred on Mortgagee to settle and compromise claims under all policies and to demand, receive, and receipt for all mones becoming payable thereunder and to assign absolutely all policies to any holder of the note or to the grantee of the real estate in the event of the lyectowere of this mortgagee and security agreement or other transfer of title to the real estate in extinguishment of the indebtednessies) secured hereby. In the event of any breach of this covenant the Mortgages may, in addition to any other rights or remedies, at any time thereafter, declare the whole of the indebtedness(es) secured hereby simmediately due and payable.

That Mortgagor agrees that the indebtedness(es) hereby secured shall at once become due and payable and this mortgage subject to foreclosure as provided for herein, at the option of holder hereaf, when and if any statement of lien is filed under the statutes of Alabema relating to the liens of mechanics and materialmen, without regard to form and contents of such statement, and without regard to the existence or nonexistence of the debt, or any part thereof, or of the lien, on which such statement is based.
- . 6. That Mortgagor shall comply with all statutes, ordinances, regulations and laws promulgated by any governmental antity asserting jurisdiction over the real estate and any and all legal requirements shall be fully complied with by Mortgagor.

That if Mortgagor fails to insure the real estate as hereinabove provided, or to pay all or any part of the taxes or assessments levied, accrued or assessed upon or against the real estate or the indebtedness(es) secured hereby, or any interest of Mortgages in either, or fails to pay immediately and discharge any and all liens, debts, and/or charges which might become liens superior to the lien of this mortgage. Mortgages may, at its option, insure the real estate and/or pay said taxes, assessments, debts, sens and/or charges and any money which Mortgages shall have so peed shall constitute a debt to Mortgages additional to the indebtedness(es) secured hereby; shall be secured by this mortgage; shall bear the interest set out in the note hereinabove referred to from date paid or incurred; and, at the option of Mortgages, shall be immediately due and payable.
