Together with all the rights, privileges, tenements, appurtenances and fixtures appertaining to the Real Estate, all of which shall be decired Resil Estate and shall be conveyed by this mortgage.

TO HAVE AND TO HOLD the Real Estate unto the Mortgagee, its successors and assigns forever. The Mortgagor covenants with the Mortgagor is lawfully seized in fee simple of the Real Estate and has a good right to sell and convey the Real Estate as aforesaid, that the Real Estate is free of all encumbrances, unless otherwise set forth above, and the Mortgagor will warrant and forever defend the title to the Real Estate unto the Mortgagoe, against the lawful claims of all persons.

For the purpose of further securing the payment of the Debt, the Mortgagor agrees to. (1) pay all taxes, assessments, and other liens taking priority over this mortgage (hereinafter jointly gailed "Liens"), and if default is made in the payment of the Liens, or any part thereof, the Mortgagee, at its option, may pay the same; (2) keep the Best Estate continuously insured, in such manner and with such companies as may be satisfactory to the Mortgagoe, against loss by fire, vandalism, malicious mischief and other perils usually covered by a fire insurance policy with standard extended coverage endorsement, with loss, if any, payable to the Mortgagee, as its interest may appear, such insurance to be in an amount at least equal to the full insurable value of the improvements located on the Raul Estate unless the Mortgagoe agrees in writing that such insurance may be in a lesser amount. The original insurance policy and all replacements therefor, shall be delivered to and held by the Mortgagoe until the Debt is paid in full. The original insurance policy and all replacements therefor must provide that they may not be cancelled without the insurance giving at least fifteen days prior written notice of such cancellation to the Mortgagoe.

The Mortgagor hereby assigns and piedges to the Mortgages, as further security for the payment of the 16th, each and every poles of hazard insurance now or hereafter in effect which insures said improvements, or any part thereof, together with all the right, title and interest of the Mortgagor in and to each and every such policy, including but not limited to all of the Mortgagor's right, title and interest in and to any premiums paid on such hazard insurance, including all rights to return premiums. If the Mortgagor fails to keep the Real Estate insured as specified above then, at the election of the Mortgages and without notice to any person, the Mortgages may declare the entire Debt due and payable and this mortgage may be foreclosed as hereinafter provided; and, regardless of whether the Mortgages declares the entire Debt due and payable and this mortgage subject to foreclosure, the Mortgages may, but shall not be obligated to maure the Real Estate for its full insurable value (or for such lesser amount as the Mortgages may wish) against such risks of loss, for its own benefit, the presents from such insurance (less cost of collecting same), if collected, to be credited against the Debt, or, at the election of the Mortgages such proceeds from such insurance (less cost of collecting the improvements located on the Real Estate All amounts spent by the Mortgages for insurance or for the payment of Liens shall become a debt due by the Mortgagor to the Mortgages and at once payable, without demand upon or notice to the Mortgagor, and shall be secured by the lien of this mortgage, and shall bear interest from date of payment by the Mortgages until paid at the rate provided in the promissory note or notes referred to hereinabove

As further security for the payment of the Debt, the Mortgagor hereby assigns and pledges to the Mortgagee the following described property rights, claims, rents, profits, issues and revenues:

- 1. all rents, profits, issues, and revenues of the Real Estate from time to time accruing, whether under leases or leasancies how existing or hereafter created, reserving to the Mortgagor, so long as the Mortgagor is not in default hereunder, the right to receive and retain such rents profits issues and revenues;
- 2. all judgments, awards of damages and settlements hereafter made resulting from condemnation proceedings or the taking of the Real Estate or any part thereof, under the power of eminent domain, or for any damage (whether caused by such taking or otherwise) to the Real Estate, or any part thereof, or to any rights appurtenant thereto, including any award for change of grade of streets, and all payments for the voluntary sale of the Real Estate, or any part thereof, in lieu of the exercise of the power of eminent domain. The Mortgagee is hereby authorized up behalf of, and in the name of, the Mortgager to execute and deliver valid acquittances for, and appeal from, any such judgments or awards.
