## MORTGAGE

THIS MORTGAGE IS DATED MARCH 5, 2000, between HARVEY G MARTIN and JAMCE E MARTIN, HUSSAND AND WIFE, whose address is 1122 LAKE FOREST CIR, BIRMWIGHAM, AL 35244 (referred to below as "Grantor"); and AmSouth Bank, whose address is 1849 Montgomery Highway, Birmingham, AL 35244 (referred to below as "Lander").

GRANT OF MONTGAGE. Grantor presently sesigns to Lander all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property in addition, Grantor grants to Lender a Uniform Commercial Code security interest in the Personal Property and Rents.

Related Documents.
