NOW THEREFORE, in consideration of the premises and of said indebtedness and in order to secure prompt payment of the same according to the terms are stipulations contained in said Promissory Note and any end all extensions and renewals thereof, or of any part thereof, and any other amounts that the Morrgages or the successors or assigns may advance to the Borrower or Mortgagor before the payment in full of said Mortgage indebtedness, and any additional interest that may become dubt on any such extensions, renewals and advances or any part thereof (the aggregate amount of such debt, including any extensions, renewals, advances and interest due thereom is hereinsafter collectively called "Debt") and compliance with all the supulations herein contained, the Mortgagor does hereby grant, bargain, sell and convey unto the Mortgages, the rest aunto described as follows:

TO HAVE AND TO HOLD the real estate unto the Mortgages, its successors and assigns forever, together with all the improvements now or hereafter erected on the real estate and all ensements, rights, privileges, tenements, appurtunances, rents, royalties, mineral, oil and gas rights, water, water rights and water stock and all fixtures now or hereafter attached to the same real estate, all of which, including replacements and additions thereto shall be deemed to be and remain a part of the real estate covered by this Mortgage; and all of the foregoing are hereinafter referred to as "Real Estate" and shall be conveyed by this Mortgage.

The Mortgagor covenants with the Mortgagee that the Mortgagor is lawfully seized in fee simple of the Real Estate and has a good right to will and convey the Real Estate as aforestid; that the Real Estate is free of all encumbrances, except as stated herein, and the Mortgagor will warrant and forever detend the title to the Real Estate unto the Mortgagee against the lawful claims of all persons, except as otherwise herein provided.

For the purpose of securing the payment of the Debt, the Mortgagor agrees to: (1) pay prumptly when due all taxes, assessments, charges, times and other bens which may attain priority over this Mortgage (hereinafter jointly called "Liens"), when imposed legally upon the Real Estate and if default is made in the payment of the Liens. or any part thereof, the Mortgagee, at its option, may pay the same; (2) keep the Reat Estate continuously insured, in such manner and by such companies as may be satisfactory to the Mortgagee; against loss by fire, vandalism, malicious mischief and other perils usually covered by a fire insurance policy with standard extended coverage endorsoments, with loss, if any, payable to the Mortgages, as its interest may appear; such insurance to be in an amount sufficient to cover the Debt. The original mustains policy, and all replacements therefor, shall be delivered to and held by the Mortgages until the Debt is paid in full. The original insurance policy and all replacements therefor inust provide that they may not be canceled without the insurer giving at least ten days prior written notice of such cancellation to the Mortgagee. The Mortgagor bereix assigns and pledges to the Mortgagee, as further security for the payment of the Debt, each and every policy of hazard insurance now or hereafter in effect which insures , said improvements, or any part thereof, together with all the right, title and interest of the Mortgagor in and to each and every such policy, including but not limited to all of the Mortgagor's right, title and interest in and to any promiums paid on such hazard insurance, including all rights to returned prematers. If the Mortgagor fails to keep the Real Estate insured as specified above then, at the election of the Morigages and without notice to any person, the Morigages may declare the entire Debt due and payable and this Mortgage subject to foreclosure, and this Mortgage may be foreclosed as hereinafter provided; and, regardless of whether the Mortgagee declares the course Debe the and payable, the Mortgagee may, but shall not be obligated to, insure the Real Estate for its full insurable value (or for such lesser amount as the Mortgagee may wish) against such risks of loss, for its own benefit the proceeds from such insurance (less cost of collecting same), if collected, to be credited against the Debt. or, at the election of the Mortgagee, such proceeds may be used in repairing or reconstructing the improvements located on the Real Estate. All amounts spent by the Mortgagee for insurance or for the payment of Liens shall become a debt due by the Borrower and Mortgagor to the Mortgagoe and at once payable without demand upon or rotice to the Borrower. or Mortgagor, and shall be secured by the lien of this Mortgage, and shall bear interest from the date of payment by the Mortgagee until paid at the rate of interest provided is for in the Promissory Note. The Borrower and Mortgagor agrees to pay promptly when due the principal and interest of the Debt and keep and perform every other coverage. and agreement of the Promissory Note secured hereby.

As further security for the payment of the Debt the Mortgagor hereby assigns and pledges to the Mortgagee, the following described property rights, claims, rents profits, issues and revenues: (1) All rents, profits, issues and revenues of the Real Estate from time to time accruing, whether under leases or tenancies now existing or hereafter created, reserving to the Mortgagor, so long as the Mortgagor is not in default hereunder, the right to receive and remin such rents, profits, issues and revenues (2) All judgments, awards of damages and settlements bereafter made remitting from condemnation proceedings or the taking of the Real Estate, or any part thereof, or to any rights apportenant thereto including any award for change of grade of streets, and all payments made for the voluntary sale of the Real Estate, or any part thereof, in here of the exercise of the power of eminent domain, shall be paid to the Mortgagos. The Mortgagos is hereby authorized on behalf of and in the name of the Mortgagor to execute and deliver valid acquitances for, or appeal from, any such judgments or awards. The Mortgages may apply all such sums received, or any part thereof, after the payment of all the Mortgagos's expenses incurried in commention with any proceeding or transaction described in this subparagraph 2, including court costs and attorney's fees, on the Debt in such manner as the Mortgagos efects, or, at the Mortgagos's option, the entire amount or any part thereof so received may be released or may be used to rebuild, repair or restore any or all of the improvements located on the Real Estate.

The Mortgagor hereby incorporates by reference into this Mortgage all of the provisions of the Promissory Note of even date herewith. Mortgagor agrees that, in the event that any provision or clause of this Mortgage or the Promissory Note conflicts with applicable law, such conflict shall not affect any other provisions of this Mortgage and the Promissory Note are severable and that, if one or more of the provisions contained in this Mortgage or in the Promissory Note shall for any reason be held to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality or unenforceable many other provision hereof; this Mortgage shall be construed as if such invalid, illegal or unenforceable provision has never been contained herein. If ensemble or expiration of applicable laws has the effect of tendering any provision of the Promissory Note or this Mortgage unenforceable according to its terms Mortgage, at its option, may require the immediate payment in full of all sums secured by this mortgage and may invoke any remedies permitted hereunder.

The Mortgagor agrees to keep the Real Estate and all improvements located thereon in good repair and further agrees not to commit waste or permit impairment or deterioration of the Real Estate, and at all times to maintain such improvements in as good condition as they are, reasonable wear and tear excepted

If all or any part of the Real Estate or any interest therein is sold or transferred by Mortgagor without Mortgagee's prior written consent, excluding (a) the creation of a lieu or encumbrance subordinate to this Mortgage (b) the creation of a purchase money security interest for household appliances (c) the transfer by devise, descent or by operation of law upon the death of a joint tenant or (d) the grant of any leasehold interest of three years or less not consuming an option to purchase. Mortgagee had not purchase, Mortgagee in the sums secured by this Mortgage to be immediately due and payable. Mortgagee shall have waived such option in accelerate if present to the sale or transfer. Mortgagee and the person to whom the Real Estate is to be sold or transferred reach agreement in writing that the creibt of such person is satisfactors to Mortgagee and that the interest payable on the sums secured by this Mortgage shall be at such rate as Mortgagee shall request

The Mortgagor agrees that no delay or failure of the Mortgagee to exercise any option to declare the Debt due and payable shall be deemed a water of the Mortgagee's right to exercise such option, either as to any past or present default, and it is agreed that no terms or conditions contained in this Mortgage shall be watered altered or changed except by a written instrument signed by the Mortgagor and signed on behalf of the Mortgagee by one of its duly authorized representatives.

After default on the part of the Borrower or Mortgagor, the Mortgagee, upon bill filed or other proper legal priocedings being commenced for the forest sure of this Mortgage, shall be entitled to the appointment by any competent court, without notice to any party, of a receiver for the rems, issues and profits of the Real Estate, with

power to lease and control the Real Estate, and with such other powers as may be deemed necessary.

Upon request of Borrower (separately or severally, if more than one), Mortgagee, at Mortgagee's option prior to release of this Mortgage, may make future advances to Borrower (separately or severally, if more than one). Such future advances, with interest thereon, shall be secured by this Mortgage when evidenced by promissory notes stating that said notes are received hereby.

UPON CONDITION, HOWEVER, that if the Derrower pays the Debt (which debt includes the indebtedness evidenced by the Promissory Note Receivedness referred to and any or all extensions and renewals thereof and advances and any interest due on such extensions, renewals and advances) and all other indebtedness secured hereby and reimburses the Mortgages for any amounts the Mortgages has past in payment of Liens or insurance premiums, and interest thereon, and fulfills all of ownigagor's obligations under this Mortgage, this conveyance shall be null and void. But if: (1) any warranty or representation made in this Mortgage is breached or proves false in any material respect; (2) default is made in the due performance of any expensant or agreement of the Mortgagor under this Mortgago; (3) default is made in the payment th the Mortgages of any sum paid by the Mortgague under the authority of any provision of this Mortgage; (4) the Debt, we any part thereof, remains unpaid at maturity. (5) the interest of the Mortgagoe in the Real Hatate becomes endangered by reason of the enforcement of any prior lien or encumbrance, (6) any statement of ten is filed against the Real Estate, or any part thereof, under the sessites of Alabama relating to the liens of mechanics and materialmen (without regard to the existence or monet istence of the debt or the lies on which such statement is bases; (7) any law is passed imposing or authorizing the imposition of any specific tax upon this mortgage or the Debt or permitting or authorizing the deduction of any such tax from the principal or interest of the Debt, or by virtue of which any tax tien or assessment upon the Real lianue. shall be chargeable against the owner of this Morigage; (8) any of the stipulations contained in this Morigage is declared invalid or inoperative by any court of competent jurisdiction; (9) Borrower or Mortgagor or any of them (2) thail apply for or consent to the appointment of a receiver, trustee or liquidator thereof of the Real Estate or of all or a substantial part of such Borrower's or Mortgagor's assets, (b) he adjudicated a bankrupt or insolvent or file a voluntary petition in bankruptcy, (c) fail, or affini in writing such Borrower's or Mortgagor's inability, generally to pay such Borrower's or Mortgagor's debts as they come dud, (d) make a general assignment for the benefit of creditors, (e) file a petition of an answer seeking reorganization of an arrangement with creditors of taking advantage of any insolvency law.
