- 5. AREAGNOMENT OF RENTS. Lender may terminate Mortgagor's license without notice and may thereafter proceed to collect the rents, royalties, income, and profits with or without the appointment of a receiver. All rents, royalties, income and profits collected by Lender or a receiver will be applied first to pay all expenses of collection, then to the payment of all costs of operation and maintenance of the Property, and then to the payment of the Obligations secured by this Mortgago in the order determined by Lender in its sold discretion.
- 6. CONSTRUCTION MORTGAGE. All such Leases and the amounts due to Mortgagor thereunder are hereby assigned to Lender as additional security for the Obligations.
- 8. COLLECTION OF INDESTEDNESS FROM TRIED PARTY. Lender shall be entitled to notify or require Mortgagor to notify any third party (including, but not limited to, lessees, licenses, governmental authorities and insurance companies) to pay Lender any indebtedness or obligation owing to Mortgagor with respect to the Property (comulatively "Indebtedness") whether or not a default exists under this Mortgagor shall diligently collect the Indebtedness owing to Mortgagor from these third parties until the giving of such notification. - 19. EVERTS OF DEFAULT. An Event of Default will occur under this Mortgage in the event that Mortgagor, Borrower, or any guarantor of the Obligations:

(a) fields to make, any physicent under this Obligation, any other document or instrument relating to the foregoing or executed in favor of Lender. or under any other indebtedness to Londor when due:

(b) fails to perform any obligations or breaches any warranty or covenant to Lender contained in this Mortgage or any other present or future written agreement regarding this or any other indebtedness to Lender;

(c) provides or causes any false or misleading signature or representation to Lender;

(d) sells, conveys, or transfers rights in the Property without the prior written approval of Lender;

(c) seeks to revoke, terminate or otherwise limit its liability under any continuing guaranty;

(f) has a garnishment, judgment, mx levy, attachment or lien entered or served against any of them or any of their property.

(g) dies, becomes legally incompetent, is dissolved or terminated, ceases to operate its business, becomes insolvent, makes an assignment for the benefit of cruditors, or becomes the subject of any bankruptcy, insolvency or debtor rehabilitation proceeding;

- 22. REIMBURSEMENT OF AMOUNTS EXPENDED BY LENDER. Londer, at Lender's option, may expend funds (including attorneys' fees and legal expenses) to perform any act required to be taken by Mortgager or to exercise any right or remedy of Lender under this Mortgage. Upon demand, Mortgagor shall immediately reimburse Lunder for all such amounts expended by Lender together with interest thereon at the lower of the highest rate described in any Obligation or the highest rate; allowed by law from the date of payment until the date of reimbursement. These sums shall be included in the definition of Obligations herein and shall be secured by the beneficial interest granted herein.
