UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

1. Payment of Principal and leterest; Prepayment and Late Charges. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.

2. Funds for Taxes and Insurance. Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next

The Note Holder will then determine the amount of the monthly payment that would be sufficient to repay the unpeld principal that I am expected to owe at the Change Date in full on the Maturity Date at my new interest rate in substantially equal payments. The result of this calculation will be the new amount of my monthly payment.

(D) Limits on Interest Rate Changes.
