First Trust National Association, as Trustee, a national banking association organized and existing under the laws of the United States of America, 180 East Fifth Street, Corporate Trust, 2nd floor, St. Paul, MN 55101 hereby constitutes and appoints First Nationwide Mortgage Corporation, and in its name, aforesaid Attorney-In-Fact, by and through any officers appointed by the Board of Directors of First Nationwide Mortgage Corporation, to execute and acknowledge in writing or by facsimile stamp all documents customarily and reasonably necessary and appropriate for the tasks described in items (1) through (4) below, provided however, that the documents described below may only be executed and delivered by such Attorneys-In-Fact if such documents are required or permitted under the terms of the related servicing agreements and no power is granted hereunder to take any action that would be adverse to the interest of the Trustee or the Holders. Demand, sue for, recover, collect and receive each and every sum of money, debt, account and interest (which now is, or hereafter shall become due and payable) belonging to or claimed by U.S. Bank Trust National Association, and to use or take any lawful means for recovery by legal process or otherwise.

Transact business of any kind regarding the Loan, and obtain an interest therein and/or buildings thereon, as U.S. Bank Trust National Association's act and deed, to contract for, purchase, receive and take possession and evidence of title in and to the property and/or to secure payment of a promissory note or performance of any obligation or agreement.
3. Execute bonds, notes, mortgages, deeds of trust and other contracts, agreements and instruments regarding the Borrowers and/or the Property, including but not limited to the execution of releases, satisfactions, assignments, and other instruments pertaining to mortgages or deeds of trust, and execution of deeds and associated instruments, if any, conveying the Property, in the interest of U.S. Bank Trust National Association.
4. Endorse on behalf of the undersigned all checks, drafts, and/or other negotiable instruments made payable to the undersigned.
