5. Hazard or Property Insurance. Borrower shall keep the improvements now existing or hereafter crected on the Property insured against loss by fire, hazards included within the term "extended coverage" and any other hazards, included floods or flooding, for which Lender requires insurance. 17. Transfer of the Property or a Beneficial Interest in Borrower. THIS PLANNED UNIT DEVELOPMENT RIDER is made this 30th day of March. 2000 and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed (the "Security Instrument") of the same date, given by the undersigned (the "Borrower") to SOURS BOTTOWE'S NOTE TO HUTSON/ELROD HORTGAGE CORPORATION

(the "Lender") of the same date and covering the Property described in the Security Instrument and located

The Property Includes, but is not limited to, a parcel of land improved with a dwelling, together with other such parcels and certain common areas and facilities, as described in

Instrument 1997-36872 and Instrument 1998-27565

(the "Declaration"). The Property is a part of a planned unit development known as VILLAGE PARRISH

[Name of Planned Unit Development]

(the "PUD"). The Property also includes Borrower's interest in the homeowners association or equivalent entity owning or managing the common areas and facilities of the PUD (the "Owners Association") and the uses, benefits and proceeds of Borrower's interest.
