**WARRANTY DEED**

**KNOW ALL MEN BY THESE PRESENTS**, that in consideration of the sum of One Hundred Forty-Eight Thousand Nine Hundred and No/100 Dollars (\$148,900.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, **OLD SOUTH BUILDERS, INC.** (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **PHILIP A. AMRELL & MELANIE D. AMRELL**, (herein referred to as "Grantee") as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 12, according to the Survey of Stage Coach Trace, Sector 1, as recorded in Map Book 25, Page 24 A, B & C, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way and covenants of record; taxes for 2000 and subsequent years not yet due and payable.

**IN WITNESS WHEREOF**, the Grantor has signed and sealed this Deed on the 31st day of March, 2000.


